General Data Protection Regulations Policy GARP - 12

Definitions

Service

Service includes the www.Gartec.com & www.aritcospareparts.co.uk websites operated by Gartec Limited, in addition to services requested by and provided to customers past, present and future by Gartec Limited, which may or may not have been requested or conducted using electronic communications.

Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Cookies

Cookies are small pieces of data stored on your device (computer or mobile device).

Data Controller

Data Controller means the natural or legal person who (either alone or jointly or in cornmon with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed.

For the purpose ofthis Privacy Policy, we are a Data Controller of your Personal Data.

Data Processors (or Service Providers)

Data Subject (or User)

Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data
